

# MORE THAN \$40,000 RAISED FOR THE DEACON HARRIS MEMORIAL FUND AT PATHWAYS!

On June 1, 2019 The Bistro at North Shore Music Theater served as the perfect setting to celebrate the life and many gifts of Deacon Winslow Harris – "Deke" as he was fondly referred to by his many friends and loved ones. Deke was only on this earth for 30 years before an undiagnosed heart condition robbed so many of the gifts he had to offer. He loved children and he loved everything Pathways stands for. The long friendship between Deacon's parents, Debra Glabeau and Ken Harris, and Pathways' President & CEO, Sue Todd, resulted in an incredible evening celebrating Deke and raising over \$40,000 for The Deacon Harris Memorial Fund at Pathways.

The evening was the perfect reflection of Deke's joie de vivre. Many people shared stories about his selflessness and generous spirit. Deke's sister liked to say that "Deke loved to paint the town orange" and over 200 guests did just that! Fond memories were shared and fabulous items were auctioned. Karaoke showcased talents and dancing capped off a most memorable evening. He lived his life committed to making our world a better place in which to live – one relationship at a time. The life-changing impact that The Deacon Harris Memorial Fund at Pathways will have on the children and families that we serve is a fitting reflection of his unique brand of energy and joy. These funds are being directed to supporting our core services to financially at-risk children and their families.

It was said that he was an instant friend to all he met. We know that even in his absence he is a friend to vulnerable children on the North Shore.



On September 22, 2018 over 320 people gathered at the DoubleTree by Hilton in Danvers to celebrate Pathways' 50th Anniversary and to honor 4 individuals who helped us to achieve that milestone. Mikki Blazak, State Representative Ann-Margaret Ferrante, Alec Dingee and Sue Todd were presented with Pathways Pioneers awards to a standing ovation and enthusiastic crowd. Respectively, they were saluted as Staff, Alum, Philanthropist and Leadership Pioneers.

The evening included cocktails and a silent auction as well as the premier of an engaging and informative video capturing all that Pathways does to support children and families on the North Shore. It was a big hit with the crowd! The beautifully decorated ballroom was a great setting for a lively Fund-A-Need that was followed by a competitive live auction helping to raise more than \$260,000 for Pathways' 5 core programs and to extend our wrap-around social work services to all Pathways families.

After the special celebration of honorees, guests dined and danced then departed with a gift of champagne to show our appreciation for their support and to thank them for joining us in celebrating our 50th Anniversary Gold Gala!

## IT'S ALL ABOUT RELATIONSHIPS

# We don't want to brag but...



Each year the Greater Beverly Chamber of Commerce (GBCC) hosts the Greater Beverly Business Awards to celebrate the dedication and commitment of the business talent and the entrepreneurial spirit that exists in that region. This upscale event recognizes the exceptional talent of the business men and women who make a difference in the Beverly community and beyond.

In February of 2019 Pathways for Children was honored to be named Non-Profit Business of the Year at the GBCC Business Awards. The commendation is presented annually to a local business that recognizes the importance of providing resources and exceptional services to the people they serve in the community. This distinction recognized Pathways as an organization that leads by example and practices servant leadership skills within our organization.


The award resulted in a wonderful night of accolades that were deftly deflected by Sue Todd as she accepted the award on behalf of our committed front-line staff of educators and social workers as well as our generous donors and volunteers.

#### ...and there's more!

Three years ago, leadership from Pathways, the City of Salem, the Salem Public Schools and Salem State University began meetings to identify social needs that a more defined collaboration between these entities could begin to address. As a result of our alliance, the City of Salem proposed that Pathways move some of our classrooms into the first floor of the Horace Mann Laboratory School. Therefore, in the fall of 2018, our previously scattered-site classrooms were consolidated and relocated to the elementary school in Salem that also houses the city's K-5 lab school affiliated with the University.

Through this cooperation, the needs of at-risk children and families and the chronic shortage of qualified early education teachers were identified as challenges to the families we serve. In response, Salem State University (SSU) and Pathways worked together to develop an internship program to support early childhood teachers. SSU students majoring in early childhood education were offered internships in our Salem classrooms to complete their "pre-practicums". After completing their SSU programming, those students are eligible to apply for a paid position at Pathways.

We're happy and proud of these accomplishments that represent the hard work of many and that help us to better serve the children and families of the North Shore and Cape Ann.

### PATHWAYS PROGRAMS SUPPORT CHILDREN AND FAMILIES

In FY19 Pathways for Children served more than 500 children from 14 communities on Cape Ann and the North Shore. Perhaps more importantly, we served those children and families in a holistic manner providing quality educational and recreational programming, supportive services and community referrals for the entire family through our comprehensive children and family-focused programs.

#### **EARLY HEAD START**

27 infants and toddlers from birth to 2.9 years learned, played and were nurtured in this center-based program

#### **HEAD START**

**368** preschoolers from age 2.9 to 5 years received comprehensive services and enrichment programs — and learned what they need to know before they enter kindergarten.

#### FAMILY ENRICHMENT PROGRAMS

117 families enjoyed family-focused outreach programs including nationally recognized workshops, parenting training and teen and parent mentoring programs.

#### SCHOOL AGE CARE

**80** students from age 5 to 13 received quality after school, school vacation and summer educational and recreational activities through 4 locally-focused enrichment programs.

# COORDINATED FAMILY AND COMMUNITY ENGAGEMENT PROGRAMS

More than **800** families took part in programs designed to enrich family life on Cape Ann through a collaborative network of educators, parents and community members.

Average monthly enrollment was 94% of funded enrollment for Cape Ann Head Start, 99% for Cape Ann Early Head Start, and 97% for North Shore Head Start.

Cape Ann Head Start served 84% income eligible children, Early Head Start served 99% income eligible children, and North Shore Head Start served 97% income eligible children.

# **VOLUNTEERS**WORKING TOGETHER FOR PATHWAYS



Our families and staff at Pathways for Children have benefitted immensely from dedicated volunteers who have given generously of their vibrant energy and many precious hours. In fact, our talented volunteers are a major reason Pathways has had such a notable impact in 14 communities on the North Shore. Volunteering at Pathways is a fantastic way to improve lives in our community and beyond, and as any of our volunteers will tell you – it feels great!

This past year, nearly 250 Pathways community volunteers donated over 8,000 hours of time in a myriad of ways helping children. These numbers would be much higher if we counted all the hours our dedicated parent volunteers put into strengthening Pathways' programs.

There is no way to place a monetary value on what is truly invaluable. Nevertheless, it's certainly amazing to see that the time donated adds up to over \$150,000 in support for Pathways' programming.

Volunteerism is key to making the Pathways experience exceptional for the more than 500 children in our programs. Whether helping out with field trips or classroom activities, assisting with administrative tasks, holding toy, book, clothing and school supply drives, or lending a hand with special events and other projects – whatever your talents are – we will find a way to put them to good use. Educators, artists, musicians, dancers, theater and school groups, athletes, yoga teachers, readers and storytellers are especially encouraged to apply!

#### EARLY HEAD START PROGRAM

Early Head Start (EHS) is our comprehensive, federally funded program serving students ages 6 weeks to 2.9 years of age. It is a center-based program, which focuses on attaining infant-toddler school readiness goals and connects directly with our families to provide support and training. Early Head Start is conducted in our Gloucester site. We provide an age-appropriate outdoor playground and indoor play space for children to run and play. EHS creates a happy, healthy setting where children are encouraged to take an active role in their own social, emotional, cognitive and physical growth. EHS recognizes each child is an important member of a unique family. Our bilingual/bicultural staff is trained to support each child's home language and culture during the critical early years. We also offer support to our EHS expectant families and parenting teens.

In FY19, 100% of our enrolled Early Head Start children and 98.5% of our enrolled Head Start children received medical exams.

#### **HEAD START PROGRAM**

Head Start (HS) is our comprehensive, federally funded education program serving children 2.9 to 5 years of age. It is a center-based program focused on attaining formal school readiness goals and helping families achieve self-sufficiency. HS is offered in Gloucester, Salem and Beverly centers. HS recognizes the whole child in the context of a unique family. Although income is the primary basis for admission, homeless families and foster children are given priority for admission and at least 10% of slots are reserved for children with disabilities. HS provides routine screenings to assess each child's development, including health and nutrition status. We also meet with parents to identify and obtain needed support or resources. We provide age-appropriate outdoor playground and indoor play space for our children to run and play.

100% of our enrolled Early Head Start and 97% of our enrolled Head Start children received dental exams.








#### **SCHOOL AGE CARE**

Pathways' School Age Care (SAC) program provides out of school time education for children from kindergarten through age 12 in our Gloucester center. These are the years in which children most easily learn to make plans and set goals, to persevere and adapt, to develop relationships and share prosocial values like personal responsibility, empathy, respect, and compassion for others. We teach these skills to equip children with the tools they need to make the best choices as young adults.

In addition to teaching the above skills, the SAC program offers homework help and recreational activities. SAC offers four (4) locally-focused educational, recreational and social/emotional enrichment programs designed to provide our school age students with the skills they need to succeed in school and in life. Those programs are: STEM Works which increases students' knowledge of science, technology, engineering and math concepts; Milestones, a character and leadership building & social emotional learning program for young people promoting successful academic and behavioral outcomes; Pathways Moves, our healthy body and mind initiative; and Community Builders which exposes students to the arts utilizing our rich Cape Ann resources.

SAC provides year-round services with part-time after school and full days during the summer and school vacations.

# COORDINATED FAMILY & COMMUNITY ENGAGEMENT

Pathways is the lead agency for the Cape Ann Coordinated Family & Community Engagement (CFCE) grant. CFCE is funded by the Massachusetts Department of Early Education and Care, which provides local, family-focused programming and services, resources and support. Families residing in Cape Ann with children ages birth to 12 years may participate in various free community programs to support parents as their child's first teacher. CFCE also coordinates community-wide resources that provide supports to address the needs of children and families. A CFCE advisory council assures that community needs are being met. The advisory council includes representatives from public schools, Early Intervention, various child/family agencies and parents.



#### GRANDPARENTS RAISING GRANDCHILDREN – CAPE ANN

In FY19 CFCE continued to provide services, information and support to local grandparents raising children. Cape Ann, like communities throughout the state and country, has seen an increase in relative caregivers due, in part, to the ongoing opioid epidemic. Working with the Massachusetts Commission on the Status of Grandparents Raising Grandchildren and representatives from local social and enrichment service providers, CFCE has spearheaded the effort to meet the needs of impacted families. A community forum & information event was held in the spring and free weekly support groups were established. Children are engaged in enrichment programming during the support group sessions. CFCE continues to offer assistance, programming and resources to grandparents, families and professionals adjusting to changes in family life.

#### **FAMILY ENRICHMENT PROGRAM**

Family Enrichment Program (FEP) provides free, high quality, evidence-based programs designed to help support and strengthen the family unit including:

- The *Nurturing Program*<sup>®</sup>: a strength-based program offered to families with children ages birth to 12. Parents learn approaches to discipline, stress management, communication and more. This year we held our first 15 week program at our Beverly Center using the Nurturing Program<sup>®</sup> for Parents of School-Age Children curriculum. Our Gloucester center offered two different curricula options: The Nurturing Program<sup>®</sup> for Parents of Infants, Toddlers & Preschoolers, and the Nurturing Program<sup>®</sup> for Parents of School-Age children.
- The *Parent Mentor Program*: mentors model healthy relationships, interact with mentees in a supportive manner, and assist them in accomplishing goals. It helps reduce isolation, enhance parenting skills, improve communication, and increase access to community resources.
- The *Teen Mentor Program*: high school students mentor young children who benefit from a positive role model. The relationship helps strengthen self-esteem, improve academic performance, reduce isolation, and model social skills.
- Parent Connection: a weekly, professionally facilitated, drop-in support group that provides parents with a forum for support and discussion.


One participant shared that she was "learning to validate feelings and appropriately talk about them with children and others...Love it!"

Two Masters of Social Work (MSW) interns - one from Salem State University and another from Simmons University - dedicated a total of 1,031 volunteer hours to FEP. One of the main intern projects of the year involved developing an online training module for the Parent Mentor Program, allowing us to reach more mentors, and thereby serve more parents, as mentors are now able to complete the training on a rolling basis as soon as they express interest in volunteering.

### **MENTORING CAN CHANGE PEOPLE'S LIVES!**

At Pathways we offer mentoring opportunities for teens and parents. This year's highlights from those programs include:

- 10 volunteer mentors for the Parent Mentor Program completed 12 hours of training with the FEP Social Worker and participated in monthly group supervision sessions for the duration of the year-long program. 12 parents were matched with mentors. One parent stated, "My mentor is someone I can talk to. She does not judge me" while another stated, "My mentor is the best. She is helpful and understanding."
- 13 high school students completed 9 hours of training through the Teen Mentor Program to become volunteer mentors for children in the community. The training focused on encouraging

# This year our parent mentors were able to support their mentees through particularly difficult times such as these:

- Supporting a family from Iraq who is new to the community and helping the mother obtain her citizenship and more recently her driving permit.
- Helping a single mother enroll in college readiness class to prepare her to start college in the Fall.
- Working with a father who speaks Spanish who recently obtained custody of his three children. The mentor provided support and a translator to help with custody and accessing resources.
